ORDINANCE NO. 2008-07 ANIMALS
AN ORDINANCE PROVIDING FOR PROTECTION OF THE HEALTH, SAFETY AND WELFARE OF THE PEOPLE OF THE CITY OF EAGLE LAKE BY CONTROLLING THE ANIMAL POPULATION AND ESTABLISHING UNIFORM RULES FOR THE CONTROL OF ANIMALS AND ERADICATION OF RABIES; ADOPTING LATEST CONTROL AND ERADICATION RULES OF THE DEPARTMENT OF STATE HEALTH SERVICES; PROVIDING FOR THE APPOINTMENT OF AN ANIMAL CONTROL OFFICER AND PRESCRIBING HIS POWERS AND DUTIES; PROVIDING THAT ALL DOGS BE VACCINATED AGAINST RABIES; PROVIDING AN OFFENSE FOR DOGS RUNNING AT LARGE OR NOT RESTRAINED; PROVIDING FOR BARKING OR HOWLING DOG NUISANCE; PROVIDING FOR CONTROL OF GUARD AND ATTACK DOGS; REQUIRING THE DETENTION OF DOGS HAVING BITTEN A PERSON; PROVIDING FOR REDEMPTION OR PLACING OF DOGS FROM THE SHELTER; PROVIDING FOR DISPOSAL OF QUARANTINED AND IMPOUNDED ANIMALS; PROVIDING FOR ADOPTION OF DOGS; PROVIDING PROCEDURES FOR THE CONTROL OF VICIOUS ANIMALS; DECLARING THE KEEPING OF WILD ANIMALS TO BE UNLAWFUL; PROVIDING REGULATIONS FOR THE KEEPING OF LIVESTOCK; PROVIDING A CRUELTY CLAUSE; REPEALING CONFLICTING ORDINANCES; AND PROVIDING A SAVING CLAUSE; PRESCRIBING A PENALTY FOR THE VIOLATION; PROVIDING FOR PUBLICATION BY CAPTION; AND PROVIDING FOR AN EFFECTIVE DATE.
