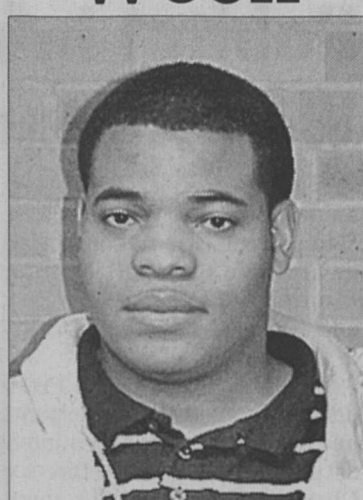

Hempstead scored 12 in the first and second quarters; 20 in the third; and 18 in the fourth.

Leading scorer for the Raiders was Damian Steven with nine points. Corey Farrow scored eight. Myles Dumont added five. Jared Kaster and Cody Lantelme each scored four points.

Farrow led the team in rebounds with five offensive and two defensive. Lantelme had one offensive rebound and five defensive. Stevens had four defensive rebounds. Dumont, two offensive, one defensive; Kaster, two defensive; JJ Reggins and Terrance Shorter each had one defensive rebound.

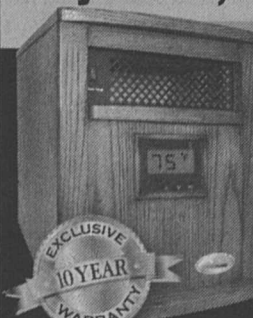
