Floodplains and Wetlands - Notice of Explanation

The City of Eagle Lake, Texas, will undertake a Sewer System Improvements project funded by the Texas CDBG Program and located at the wastewater treatment plant just east of South McCarty Avenue in the southern area of Eagle Lake. The project site is within the 100-year floodplain. The City of Eagle Lake considered relocating or terminating the project; however, relocation would exceed available program funding and termination would result in continued unsafe/unsanitary conditions. Negative impacts (erosion, noise, pollution) will be mitigated using proper construction techniques overseen by a professional engineer. In the City's judgment Executive Orders 11988/11990 have been considered in proceeding with this project to improve existing facilities. Floodmaps and project information may be reviewed at City Hall. Public comment will be accepted until February 18, 2010, at the City of Eagle Lake, P.O. Box 38, Eagle Lake, TX, 77434-0038 during regular business hours.

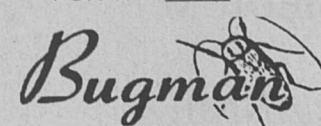

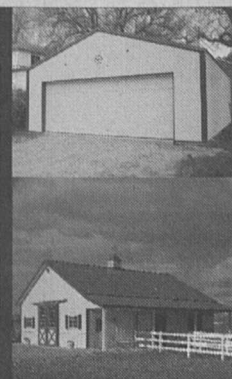
