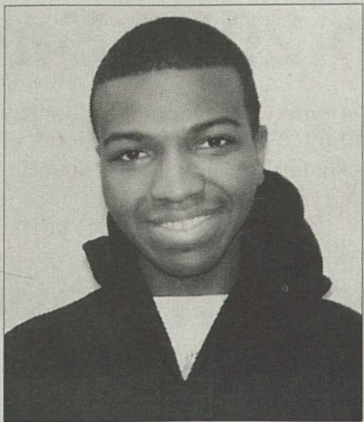
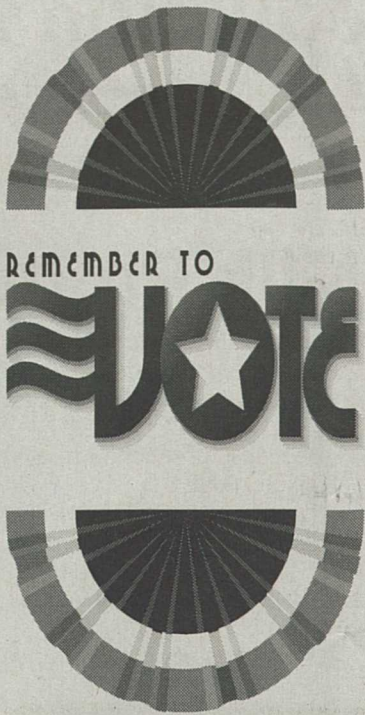


Raider of the Week

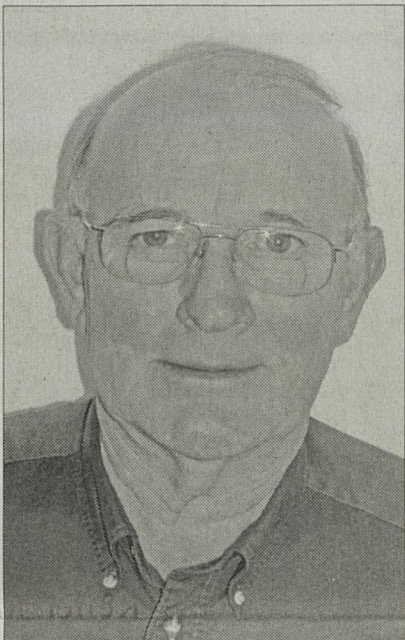


friends. Next year Dillan will enter Sam Houston State University to begin his studies toward becoming a registered nurse.
