Five Lawsuits Filed in District Court Recently

Five lawsuits were filed in Colorado County District Court recently.

On Feb. 26, Michael Martin filed suit against Jo Allen Davidson arising from a Sept. 14, 2009, auto accident.

The suit states that Martin owns a trucking company.

According to the suit, one of Martin's drivers was on FM 3013 in Colorado County when the vehicle was struck by a vehicle driven by Davidson, who had pulled into the southbound lane of traffic.
